1. Minutes of the 2022 AGM held on 6th November 2022

There were no matters arising. The minutes were accepted by a majority vote.

2. Chair's Report

Bob welcomed members to the AGM. He thanked Mandy and Celia for providing lunch for those who had been on the morning walk.

3. Treasurer's Report

Brian's report is appended to these minutes. The 2022/2023 Income and Expenditure Account and the Balance sheet are also appended.

The Accounts had been audited by Tony Sheward and been approved and signed off. Members voted to accept the 2022-23 IVW Financial Accounts. Proposed by Chris Burns and Seconded by Mandy Wisson

4. Officers Reports

The reports from Roy Carter (Membership), Roger McLeod (Social and Programme), Derek Turner (Footpath and read out by the Chair), and Tom Collier (Publicity) are attached to these minutes.

5. Election of Officers

All of the Committee had agreed to remain in their posts for the next year. Nomination forms had been received for each Committee post. As there had been no other nominations all the Committee members were approved by a majority vote.

6. Appointment of the Independent Examiner

Tony Sheward was proposed by Sue Tate and seconded by Barry Ingram and was accepted by a majority vote.

7. Adoption of IVW Constitution 2023

At the 2022 AGM the incoming Chair said that the new Committee would change their working practices to make them transparent and up to date. A revised Constitution would be brought to the 2023 AGM for approval and Group Reserves Policy and Committee meeting procedures and etiquette would be laid out. These documents had been circulated to members 28 days before this 2023 AGM. Minor modifications had been made following comments received. The final versions of the document had been sent to members with Agenda for the 2023 AGM. After discussion, the documents were agreed by members unanimously. 8. Bedfordshire Ramblers Area Matters

a) With no chair for 2022/23 the Chairs of Leighton Buzzard, North Beds and Ivel Valley had met

quarterly with Vanessa Swanson (Regional link Officer at Ramblers Headquarters)

- b) Kevin Barrett had continued at Area Treasurer so money continued to flow through to the Groups. However, it was noted that Kevin has resigned from that post as of November 2023 as he has relocated away from Bedfordshire.
- c) A Festival of Autumn Walks had been organised by the LB Group and supported by the other Groups.

9. Any Other Business

- a) Barry raised a point about Signage for the North Beds Heritage Trail. He said that signage was deficient, and more discs were needed. He reported that a few years ago it was agreed at Area level that IVW would be responsible for replacement of signs. The Route had been devised by Gorgen Edwards a long time active member of IVW. Bob agreed to take this to the January IVW Committee meeting to discuss further.
- b) Rachel Bryce asked if the 40m Greensand Ridge Challenge that takes place over two days during the Bedfordshire Walking Festival could be also split over four days as part of our 40th Birthday celebrations in 2024. Bob said that this would be considered by the Committee.
- c) Bob, as Chair, said that there a great need to plan succession for Committee members. Roger down would be standing as Programme Secretary at the 2024 AGM. Bob, at this time, would not commit to carrying on as Chair beyond the 2024 AGM. He also pointed out IVW had a great need for someone to run the IVW website this need not necessary be a Committee post.

Ivel Valley Walkers Finance Report for 2023 AGM

This is my first year of presenting the accounts and I have tried to present them in a similar manner to last year. If anyone has any ideas as to how the presentation could be improved, please let

me know.

Please note that when I am referring to last year, this year, or next year, I am referring to the financial year. This financial year, for which I am presenting the accounts, is from 1_{st} . October 2022 to 30_{th} . September 2023.

Administration Account

The first sheet shows the income and expenditure for this year. Any money owed from last year (eg Q4 payment from area) is not shown as income for this year.

We started the year with £902 in the Admin account, which was a bit on the high side, considering our level of expenditure last year. We didn't submit a budget last year (for this year), but we devised an internal budget which would reduce the account to a more reasonable level. This budget included two printed programmes, the spring programme, and the summer programme. A third programme could have depleted the reserves too much. However, we managed to obtain £200 income from advertising to help cover the costs of the autumn programme.

The deficit for this year was £616.

We have submitted a budget for next year which allows for the production of three printed programmes. The budget has not yet been approved, but we are anticipating that it will be.

Social Account

Payments and expenses from last year, for this year's events, are included in the accounts. Similarly payments made this year for next year's events, and any expenses already incurred, will be carried forward to next year's accounts.

The rationale of the Social account is that all activities should be self-funded and aim to break even. It is necessary to have some reserves to cover events which fail to break even, and to prevent cash flow problems. If the reserves are too high, some events may be subsidised.

I have listed all the activities for this year. You can see which activities made a surplus and which ones were in deficit. The Christmas Lunch was intentionally subsidised, as was the Yomp, Chomp & Roll-Up.

It was agreed that members who had signed up for the original Lake District Trip to Ambleside, and had been unable to go on either of the rescheduled trips, should be given a refund. 11 refunds were given at a cost of £165.

The deficit on the Social Events Fund for this year was £419.

During the year, we received a kind donation of £500 from one of our members. This has been placed into a designated fund, referred to as the Special Events / Hardship Fund.

Balance Sheet

The left side of the sheet shows the value of our assets. These include the money we have at the bank plus debtors. Debtors can include money owed to us and expenses paid in advance, including payments which have been amortised, ie. spread over several years.

The right side of the sheet shows the value of the funds, not the same thing as the corresponding account balance. The Social Account now contains money related to two separate funds. The accumulated fund is just the sum of all the funds.

The current value of the funds should be equal to the value brought forward from last year plus the surplus or deficit for this year. If we add in the creditors, payments made in advance by members for next year, this should balance with the assets.

The fund values at the end of the year were:

- Administration Fund £679
- Social Events Fund £778
- Special Events / Hardship Fund £485

Independent Examination

The accounts as presented today have been independently examined by Tony Sheward.



IVW Membership Secretary Report



IVW member changes over the past 24 months





Member Changes in the last 12 months - Members



Both the graphs above chart the changes in IVW membership over a two-year period from

October 2021 to September 2023. The top graph year is 2022, the bottom graph year is 2023. The top graph shows large up and down falls but the actual numbers involved are small – whereas the bottom graph shows a significant reduction in numbers across the whole year.

The net difference across last year (Oct 21 – Sept 22) was a gain of two members and the membership was pretty steady but that cannot be said this year (Oct 22 – Sept 23) where the net difference is a loss of twenty-four members and a cause for concern.

By delving into the Ramblers database, I find that, although 26 members joined IVW this year they were cancelled out by 50 members leaving the Group. There are several reasons:

- 18 members transferring to other Ramblers Groups the majority earlier this year.
- 32 members either resigning or letting their membership lapse the majority let it lapse.
- The appeal to walk or find a walk with IVW no website, less walk information and variety.

There was an illustration of membership in the report last year showing a snapshot of info to support stable membership for September 2022, (see the Table below). I have reproduced the illustration to show the change this year as a comparison snapshot for September 2023. Compare.



However, we are supported well with 30 Affiliate members who are welcome to lead walks for IVW and join us in our events and holidays throughout the year.

Another detail that can be extracted from the Ramblers database is statistics detailing the makeup of the IVW membership to help us promote membership and target expenditure. This is also shown for September 2023 (see the Table below).

Email consent



Giving consent to be contacted by email

The Ramblers Association and IVW continue to only use your personal data in accordance with the consents you have given. Your personal data is stored centrally in the Ramblers Association database, which is updated daily. Membership Secretaries do not keep lists of members or make changes to membership. Instead, for each mail sent out we download the relevant contact list and consents from the database, use it and then destroy all traces of it.

The majority of members have given their consent for us to contact them by email, saving us time and money. Thank you. However, from the statistics in the table above, we still have 15% who've opted out, which meant posting out 22 letters informing members of the AGM.

If you would like to amend your consent so you can be contacted by email, you can contact the Ramblers Association directly, or ask me / the Membership Secretary to assist you.

Ramblers Membership Fees

This year's review of the Membership fees have been approved by the Ramblers board of trustees and there will be a slight increase in the fees taking effect from 2nd October 2023 for new members or on the date of the next renewal for existing members

.

Individual Annual Membership is going up by £2.50 from £38.50 to £41.00 (£3.42 /month). Joint Annual Membership is going up by £3.25 from £51.75 to £55.00 (£4.58 /month). Individual Lifetime Membership is now £898.75 & Joint Lifetime Membership is £1112.50. Concessionary rates are also available for Individual, Joint & Lifetime Memberships. (eligibility: on state pension only or on means tested benefit or a student) The Ramblers thank you for your ongoing support and say that Ramblers membership still represents good value for money and continues to provide great benefits.

IVW Footpath Secretary's Report – 2023 AGM

- The well-used path along the eastern side of the River Ivel from Langford Mill to Jordan's Mill near Broom, part of the Ivel Valley Walk, is not registered as a right of way. A local resident asked if we could support making it one. We contacted the local Central Bedfordshire Councillors who are aware of the situation, support the path becoming a right of way and are keeping in touch with the footpath officers. I understand that the landowner is not against the proposal but is unable to agree to it for the time being.
- Across the river from this path and following clearance by the RIPPLE team, there is now a path on the western side of the Ivel passing around Broom South quarry. I am told that it will be formally dedicated as a Public Right of Way shortly.
- To the east of Langford, the paths around the wind farm and the link past Topplers Hill water tower towards Edworth should also be formally dedicated soon. These paths will then be added to future Ordnance Survey Maps.
- The new bridleway bridge over the railway north of Biggleswade to replace the Lindsells level crossing is nearing completion. Central Bedfordshire Council are planning to rationalise nearby Public Rights of Way to fit in with the new arrangements and agree with the routes on the ground that people use.
- Overall, local councils such as Central Bedfordshire Council continue to be starved of cash and rights of way work is low on the political agenda. There seems to be little money for making progress with claims for missing paths, some outstanding for 10 years or more, or for expensive jobs like bridge replacement. Some paths are closed until these are carried out.
- I was unable to attend consultation events about the East-West rail-link earlier in the year but it appears that the route across our area is now certain to pass north of Ravensden and Wilden. The new station where it crosses the East Coast main line is now likely to be at Tempsford (rather than St Neots South) beyond which the alignment would follow the new route of the A428 from the Black Cat roundabout into Cambridgeshire. This will save Roxton being tightly enclosed by busy roads but be convenient for the development of Tempsford airfield. When more detailed maps become available, we shall have to scrutinise them to see how public rights of way will be affected.
- The Committee discussed revitalising the Local Footpath Officer scheme where IVW members monitor paths in an agreed area on a regular basis. I have not had time to pursue this further recently but invite members to consider which parishes they can cover.
